BRIDGET G. BRENNAN

Special Narcotics Prosecutor for the City of New York

Bridget G. Brennan has been New York City's Special Narcotics Prosecutor since 1998. Appointed by New York City's five elected District Attorneys, Ms. Brennan is the first woman to hold that position. Ms. Brennan is in charge of an agency solely dedicated to the investigation and prosecution of narcotics offenses in New York City.

The Office of the Special Narcotics Prosecutor is widely recognized for its legal and technological expertise. It processes an average of 3,000 arrests a year, prosecutes national and international drug trafficking and money laundering organizations, and oversees large-scale operations targeting violent drug gangs in New York City neighborhoods. In addition, Special Narcotics runs programs that offer treatment instead of prison to hundreds of addicted defendants every year.

Ms. Brennan joined the office in 1992 and served as the second in command from 1995 to 1997. Prior to that, she was the Chief of the Special Investigations Bureau, overseeing some of the most significant narcotics investigations in the country.

Ms. Brennan has been a prosecutor since 1983 when she joined the New York County District Attorney's Office as an Assistant District Attorney. While there, she handled hundreds of misdemeanor and felony prosecutions, including homicides and sex crimes cases.

Before her legal career, she was a print, radio and television reporter in her native Wisconsin. Ms. Brennan graduated from the University of Wisconsin Law School with a Juris Doctor degree. She holds a Bachelor of Arts degree in Journalism from the University of Wisconsin.



GLORIA J. BROWNE-MARSHALL

Gloria J. Browne-Marshall is an Associate Professor of Constitutional Law at John Jay College and a member of the Gender Studies faculty. Prior to academia, she was a Civil Rights attorney for the Southern Poverty Law Center, Community Legal Services of Philadelphia, and NAACP LDF.

Professor Browne-Marshall is a legal correspondent covering the U.S. Supreme Court, United Nations, and international as well as domestic legal issues related to women, children, minorities, and immigrants as well as criminal justice and civil rights. Gloria covered the 2012 Presidential campaign and President Obama's receipt of the Nobel Peace Prize in Oslo, Norway.

Gloria Browne-Marshall is Founder/Director of The Law and Policy Group, Inc., a 501(c)3 'think tank' for the community which publishes "The Report on the Status of Black Women and Girls(r)," the only ongoing report on the state of Black females in America.

Gloria is the author of "Race, Law, and American Society: 1607 to Present" and "The Constitution: Major Cases and Conflicts" (Pearson). Her forthcoming book is titled "She Took Justice." She is a legal correspondent covering the U.S. Supreme Court, United Nations, and international as well as domestic legal issues related to women, children, minorities, and immigrants as well as criminal justice and civil rights. Gloria covered the 2012 Presidential campaign and President Obama's receipt of the Nobel Peace Prize in Oslo, Norway.

Her weekly column on social justice issues is published in the Milwaukee Courier and syndicated in newspapers in New York City, Chicago, Dallas, Atlanta, and St. Louis, MO. She is an award-winning journalist and a member of the National Press Club. She has provided commentary for BBC America, CNN, ABC, NPR, C-Span as well as regular legal commentary for WVON (Chicago), WPFW (Washington, DC), and WBAI (NYC). Her radio program "Law of the Land" is broadcast on WBAI 99.5F (New York).

Gloria is the recipient of many awards including the NAACP Ethel Lawrence Trailblazer Award, Association of Black Women Attorney's Service award, the New York County Lawyers' Ida B. Wells award for her work on gender and race issues, the Woman of Excellence in Law award from Wiley College (Texas), and the Community Action Award from Black Star News. She speaks nationally and internationally about racial justice, multiculturalism, and the protection of vulnerable groups under Constitutional and International law.

She is a member of the U.S. Supreme Court bar, National Press Club, Pen American Center, the Supreme Court Historical Society, NAACP, and Women's City Club of New York City.

Hannam also had an opportunity to participate in the Harvard Law School Exchange Program while attending the University of California, Berkeley School of Law (Boalt Hall). Hannam earned her undergraduate degree with a minor in sociology and a Certificate in Dispute Resolution, graduating summa cum laude at John Jay College of Criminal Justice of the City University of New York.

Hannam founded and is the Chief Managing Partner of the Law Office of Sabrina N. Hannam, LLC ("Hannam Law"), a New York-based firm. Hannam Law that applies a holistic approach to contract negotiation, financial management, and community involvement on the part of its sports and entertainment clients. He was previously the Paralegal Program Director of Thomas Edison State College's online paralegal and nurse paralegal certificate programs offered in partnership with the New York Times Knowledge Network. At Thomas Edison he also mentors undergraduate and graduate level legal courses and has served on various committees including several terms as the President of the College's Academic Council. He has been active in legal education for over 30 years, serving on the Board of Directors and most recently as the President of the American Association for Paralegal Education (AAfPE) where he founded the AAfPE Technology Task Force and the AAfPE Writing Task Force. He has been an active team member with various national paralegal accrediting agencies, including the Distance Education Training Commission (DETC), affiliated with the Council of Higher Education Accreditation Commission (CHEA) of the United States Department of Education. He has also served as a civilian and military paralegal program and course reviewer with the American Council on Education (ACE) in Washington, D.C. and with National PONSII in Albany, New York. He is currently a member of the Editorial Board of *Paralegal Today* and a member of the Advisory Board of the New York City Paralegal Association.

THOMAS GOLDMAN, J.D.

Thomas Goldman is a Professor Emeritus at Bucks County Community College. He is a graduate of Boston University and the Temple University School of Law. Professor Goldman has been actively involved in the private practice of law as well as in paralegal education with an emphasis in technology education for many years. He was the founding member of the Technology Task Force of the American Association for Education (AAfPE). He has lectured and consulted extensively with educational

institutions, law firms and corporations on legal technology issues. Professor Goldman is the author of numerous texts including *The Paralegal Professional; Technology in the Law Office; Civil Litigation: Process and Procedure; and Litigation: E-Discovery and Technology.*

W. Zehava Schechter, Esq. concentrates her private practice in real estate law, estate planning, and estate administration, contracts, and business formation and dissolution.
